

CROW RIVER EQUESTRIAN
RELEASE OF ALL CLAIMS OF LIABILITY,
ASSUMPTION OF RISK, AND INDEMNIFICATION AGREEMENT
Annandale Facility

WARNING, THIS AGREEMENT IS LEGALLY BINDING, by signing it you give up your right to recover compensation through the courts of or otherwise, for any personal injuries or damage to your property, or for your death, arising out of your use of the Crow River Equestrian facility, horses, equipment, or from instruction from Corey or Brenda James, Melissa Regouski or Jennifer Woods. This release is binding even if the released entity or persons have contributed to your injuries or death through individual or collective negligence.

ASSUMPTION AND ACKNOWLEDGEMENT OF RISK

I, the undersigned, acknowledge and agree that the use of the facilities, horses or equipment of Crow River Equestrian, Corey and Brenda James, has the INHERENT RISKS of other persons. Those risks include but are not limited to:

- 1) Injuries resulting from the negligence of Crow River Equestrian or Corey and Brenda James, their agents and assigns, or the negligence of other persons.
- 2) Injuries or death resulting from the failure or negligent misuse of Crow River Equestrian facilities, horses or equipment.

I am aware of these and NUMEROUS OTHER INHERENT RISKS in using Crow River Equestrian facilities, horses and equipment. I FREELY AND VOLUNTARILY ASSUME COMPLETE RESPONSIBILITY for those risks and for the injuries that may occur as a result of these risks EVEN IF voluntarily assuming the risks involved. I will be SOLELY RESPONSIBLE for any loss or damage that I may sustain, including PERSONAL INJURIES to me, to my property, or damage arising out of my death. This release is for negligence and not for injuries resulting from gross negligence or intentional acts.

RELEASE AND PROMISE NOT TO SUE

In consideration of my using Crow River Equestrian facilities, horses or equipment, I hereby agree to RELEASE FROM ALL OF MY LIABILITY DISCHARGE AND PROMISE NOT TO SUE Crow River Equestrian, Corey and Brenda James, Melissa Regouski, or Jennifer Woods, or any of their agents, assigns, or volunteers. This agreement releases the aforementioned persons from any liability to me, my heirs, assigns, or personal representatives, for any losses or damages or claims arising out of my personal injuries, damage to my property or from my DEATH. I understand that I am releasing the aforementioned persons from ALL LIABILITY even if their individual or collective negligence contributes to or causes personal injuries or damages to my personal property of DEATH.

INDEMNIFICATION AGREEMENT

In consideration of using Crow River Equestrian facilities, horses or equipment, I agree to indemnify and hold harmless, and they are hereby RELEASED and DISCHARGED by me from any loss, liability, damages, or cost that they may incur sue to the presence of any claims or actions by me, my heirs, my assigns, or personal representatives, arising out of my using the facilities, horses or equipment of Crow River Equestrian, including, but not limited to, indemnifying and holding them harmless from all claims or suits which may arise from training, teaching or coaching on the premises.

If any provision of this agreement is held invalid, the invalidity shall not affect other provisions of the agreement, which can be given without valid provisions, and to this end the provisions of the agreement are to be severable. This release, waiver, assumption and indemnification agreement shall be effective upon execution until revoked in writing.
